#### **Description of first aid measures**

Eye: Not expected to cause prolonged or significant eye irritation.

**Skin:** Skin contact may cause drying or defatting of the skin. Symptoms may include pain, itching, discoloration, swelling, and blistering. High-Pressure Equipment Information: Accidental high-velocity injection under the skin of materials of this type may result in serious injury. The initial wound at the injection site may not appear to be serious at first; but, if left untreated, could result in disfigurement or amputation of the affected part.
